RE: Urgent Need for Action to Address Homelessness and Tent City Impact on Downtown Businesses

Dear Mayor Bowman and Esteemed Council Members,

I hope this letter finds you in all well. As the Executive Director of the Fort McMurray Chamber of Commerce, I write to you today on behalf of the downtown business community, raising a pressing concern that demands immediate attention and action.

Over the past several months, an area of our downtown has experienced a significant challenge due to the emergence of a tent city, attracting individuals struggling with homelessness and addiction issues. While we acknowledge the complexity and multifaceted nature of these challenges, the close proximity of the tent city to numerous businesses, including establishments catering to children, has resulted in substantial negative consequences.

Business owners in this downtown area, who have invested their time, resources, and passion into creating vibrant spaces, are now confronted with a difficult situation. The presence of the tent city has led to increased incidents of aggressive behavior, and petty crimes. These activities have not only disrupted the daily operations of businesses but have also instilled fear and concern among employees, customers, and the community at large.

The businesses directly affected include family-friendly establishments, where parents and guardians no longer feel comfortable bringing their children due to the potentially hazardous environment. The negative impact on the livelihood of these business owners, as well as the reputation of our downtown area as a safe and welcoming place, cannot be overstated.

We recognize that homelessness and addiction are complex social issues that require compassionate and comprehensive solutions. As the regional leaders, we turn to you for your guidance, support, and commitment to addressing these challenges effectively and with a sense of urgency.

We respectfully request that the Regional Municipality of Wood Buffalo take immediate action to:

 Collaborate with relevant stakeholders, including social service agencies, law enforcement, and community organizations, to develop a comprehensive strategy to address the tent city situation.
